#### **OCTOBER MEETING**

**Pioneer Festival:** The October meeting was held during the Pioneer Festival at the Crafts Center on the Natchez Trace. CWG members, dressed in period costumes, demonstrated carding and spinning to curious onlookers who packed the grounds.

**Show-and-tell:** The show-and-tell session included Hazel Howell's summer-and-winter experiments (from Donna Sullivan's "Summer and Winter: A Weave for All Seasons") and Tina Bradford's first steps in machine knitting (3 sweaters!). Nancy Landrum displayed the lovely herringbone shawl from last spring's sheep-to-shawl.

**YOAC recommendations:** Members approved three recommendations presented by Hazel Howell that concern activities in conjunction with our Year of American Craft Traveling Show. CWG members received these recommendations in the mail prior to the October meeting. They include:

-a party for CWG members and their guests as members jury work for the traveling show;

-the creation and distribution of invitations for the show's March 28 reception; and

-CWG sponsorship of a category award of \$25 for a traveling show entry.

YOAC invitations: Each member will mail her own invitations to the YOAC show reception March 28. Margaret Pittman (invitations chair) must know how many reception invitations each member will need for mailing. Please be prepared to tell her at the January meeting, or, if you can't make that meeting, write or call her with your number.

YOAC volunteers needed: Hazel Howell announced that the YOAC show committee will ask at the November meeting for committee volunteers to help with various duties. There's a lot to be done to make this wonderful event a success, and we need your help! Be prepared to volunteer for one (or more) of the following committees:

- -Catalog

- -Education (needs help with loom set-up for seminars)

- -Entries receiving (to receive show entries at Ag Museum on March 10)
- -Refreshments (during juring party and traveling show reception)

# **YOAC Traveling Show Committee**

#### Hazel Howell, chair

The show committee met after the business meeting at the Pioneer Festival, discussed a lot of details and nailed down some. The committee decided to ask for volunteers for show committees to sign up at the Nov. meeting. If you can't come to the Nov. meeting, you can write Hazel Howell and volunteer. We need this to be a real guild experience. (See minutes in this newsletter for list of committees.)

**Update on developments:** We have signed a contract with Donna Sullivan. Excerpts below:

The exhibition will be juried on Friday, March 19, 1993. The two days of seminars will run from (six-hour maximum instruction, plus breaks) 9-12 a.m. and 1-4 p.m. on Saturday, March 20, and Sunday, March 21, 1993. The maximum number of students is 25.

In consideration of these services, the sponsor will:

- 1. Pay \$200 upon completion of the jurying;
- 2. Pay \$500 upon completion of the seminars;
- 3. Provide transportation expenses;
- 4. Provide room and board in a separate bedroom in the home of a guild member, whose name, address and phone number will be provided at least one month in advance (preferably Marcy Petrini).

The sponsor will supply a room suitable for the jurying. The sponsor is requested to copy one set of *Donna Sullivan's Evaluation Criteria* for each item submitted to jurying (they may be copied two per page and then cut in half). The sponsor will also provide two assistants with clipboards and pens; coffee will be available for the juror.

The sponsor will provide a classroom suitable for the seminars, as well as slide projector with screen and two carousels, blackboard with chalk and eraser, two tables for layout, one stool and nametags for seminar participants. The sponsor has permission to supply one unaltered copy of the copyrighted handout to each participant at the seminar opening; no other copies are authorized.

The instructor is willing to donate part of an evening on Friday or Saturday to discuss HGA's COE-Weaving program for interested members, if desired.

We now have the following awards promised:

# **Donna Sullivan Seminars**

The Chimneyville Weavers Guild is sponsoring two one-day seminars led by nationally known weaver Donna Sullivan, author of "Summer and Winter", at the Chimneyville School of Crafts and Design, Craftsmen's Guild of Mississippi, on the grounds of the Mississippi Agriculture and Forestry Museum in Jackson, Mississippi.

Seminar topics are:

# **Summer & Winter: A Weave for All Seasons**

Summer and winter is the most economical tied unit weave. In the workshop, weavers will explore traditional and modern treadlings: two blocks, four-shaft four blocks, textured treadlings, transparency, warp patterning, related tied weaves and more. All levels.

# **Color Interaction for Handweavers**

Weavers will explore the magical way color interacts uniquely with different types of structures: plain weave, twills, laces, supplementary warps and wefts, surface texture weaves, double weaves and warp-faced weaves. The mini-gamps and samples of different color harmonies (neutral, monochrome, analogous, triad, split complement and complement) demonstrate how to effectively control hue, value and intensity in various weaving situations. All levels.


